God is in Charge, Now and Forever

Daniel was a prophet who could interpret others' dreams. Many of us are quite familiar with the stories of Daniel interpreting the dreams of King Nebuchadnezzar. But God also spoke to Daniel in his own dreams—dreams in which God revealed important truths about the End Times. Daniel's apocalyptic dreams are full of complex symbolism and otherworldly images. At times, they can be mystifying. Christians throughout history have tried to precisely identify the meaning of each and every number and image found in Daniel's dreams. However, when we study Daniel 7-12 and focus solely on finding correlations or solving puzzles, we can miss the important overarching truths. Join us as we study Daniel's dreams and prayer to find assurance of God's constancy and power, and to remember that only God's kingdom will endure forever. Let us rejoice together that we can entrust our lives to God because he alone is sovereign now and always.

READ Daniel 7-12

REFLECTION After listening, consider the following questions:

- Why do you think some Christians are drawn to trying to predict the future or identify a literal interpretation of Daniel's dreams? Where do you typically fit—do you think there is a literal interpretation or are you more comfortable identifying the odd symbols and numbers as symbolism and accepting the mystery?
- As hosts Scott Hoezee and Darrell Delaney discuss in segment 2, Daniel's prayer in chapter 9 marks the first time we hear any Israelite confess Israel's communal sin while in exile. Daniel is likely guilty of some of these sins, but he also probably confesses sins he didn't personally commit. What do you think about the idea of confessing your community's current and past sins? How does that make you feel? What do you think might be achieved by doing so?
- Why do you think Daniel's dreams and God's interpretations motivated Daniel to respond with repentance and petition for himself and his fellow Israelites? Do you think Daniel's experiences in exile (Daniel1-6)bolstered his confidence in God's mercy? Why or why not?
- In segment 3, Darrell and Scott describe us modern Christians as living in our own kind of exile. What do you think they meant by that? Do you agree or disagree? Why? Is there another way you would describe what it is like to be a Christian in the world today?
